

Privacy Policy

This legal text gives you details of how we collect and process your personal data through the use of our website www.quartiersproperties.com, including any information you may provide to us through the site when you contract a you register for our newsletter or provide your contact details through the form enabled for this purpose.

By providing us with the data, we inform you that our services are not possible for those people who are prevented by the regulations from giving consent, so when you send us the forms you guarantee that you have sufficient capacity to grant Consent.

QUARTIERS PROPERTIES HOLDING, S.L, is responsible for your data. (Hereinafter we or ours).

2. What data do we collect?

The EU General Data Protection Regulation tells us that personal data is all information about an identified or identifiable natural person, i.e. all information capable of identifying a person. This would not include anonymous data, nor percentage data.

On our website we may process certain types of personal data, which may include:

- Identity details: first name and surname.
- Contact details: email and phone.

We do not collect any data relating to special categories of personal data (those that disclose your ethnic or racial origin, political opinions, religious or philosophical beliefs, trade union membership and information about your health, genetic data biometrics).

If you are required to collect personal data by law or under the terms of contract between us and you refuse to provide it to us, we may not be able to perform such contract or provide the service, and you must inform us in advance.

3. How do we collect your personal data?

The means we use to collect personal data are:

- **Through the form of our website, through our contact email, by phone or postal mail, when:**
 - Request information about our products or services Contrata la prestación de nuestros servicios o productos
 - Request a Budget
- **Through technology or automated interactions:** on our site we may automatically collect technical data about your equipment, browsing actions and usage patterns. This data is collected through cookies or similar technologies. If you would like to expand the information, you can consult our cookie policy here ([link](#))
- **Through third parties:**
 - **Google:** analytical data or search data. Outside the European Union.

4. Purpose and legitimacy for the use of your data.

The most common uses of your personal data are:

- For the conclusion of a contract between QUARTIERS PROPERTIES HOLDING, S.L and you.
- When you consent to the processing of your data.
- When we need them to comply with a legal or regulatory obligation.
- When necessary for our legitimate interest or of a third party.

The User may revoke the consent given at any time by sending an email to Dataprotection@quartiersproperties.se or by consulting the exercise of rights section below.

Below we attach a table in which you can consult the ways in which we will use your personal data and the legitimacy for its use, in addition to knowing what type of personal data we will process. Purpose: We will only use your data for the purposes for which we collect it, unless we reasonably believe that we should use it for another reason, notifying you in advance so that you are informed of the legal reason for its processing and provided that the purpose is compatible with the original purpose.

Conservation period: They will be kept for the time necessary to fulfill the purpose for which they were collected and to determine the possible responsibilities that could arise from that purpose and the processing of the data. The provisions of the different regulations regarding the storage period shall apply, as is applicable to this treatment.

5. Your Data Protection Rights

How to exercise these rights? Users may send a communication to the registered office of QUARTIERS PROPERTIES HOLDING, S.L or Dataprotection@quartiersproperties.se email address, including in both cases a photocopy of their ID or other similar identification document, to request the exercise of the following rights:

- **Access** to your personal data: you can ask QUARTIERS PROPERTIES HOLDING, S.L if you are using your personal data.
- To request its **rectification**, if they are not correct, or to exercise the **right to be forgotten** with respect to them.
- To request the **limitation of the treatment**, in this case, they will only be kept by QUARTIERS PROPERTIES HOLDING, S.L for the exercise or defense of claims.
- To **oppose** it's processing: QUARTIERS PROPERTIES HOLDING, S.L will let you process the data in the way you indicate us, unless for legitimate reasons or for the exercise or defense of possible claims, these must continue to be processed.
- To the **portability** of the data: in case you want your data to be processed by another firm, QUARTIERS PROPERTIES HOLDING, S.L, will facilitate the portability of your data to the new controller.

Claim to the AEPD: if you consider that there is a problem with the way in which QUARTIERS PROPERTIES HOLDING, S.L is processing your data, you can direct your claims to the corresponding supervisory authority, being in Spain, the competent for it: [Spanish Data Protection Agency](#).

We may need to ask you for specific information to help us confirm your identity and guarantee your right to access your personal data (or exercise any of the other rights mentioned above). This is a security measure to ensure that personal data is not disclosed to any person who is not entitled to receive it.

All requests are resolved within the legal period indicated 1 month. However, it can take more than a month if your request is particularly complex, or if you have already performed a number of actions before. In this case, we will notify you and keep you updated.

6. Access to personal data for the provision of services

It is possible that, in the performance of our work, we need the help of third parties (processors), who only process the data to provide the contracted service, and with which we have the corresponding measures to guarantee their rights:

- Service providers providing systems management and information technology services.
- Professional advisors including lawyers, auditors and insurers who provide banking, legal, insurance and accounting consulting services

All the processors to whom we transfer your data will respect the security of your personal data and process it in accordance with the GDPR.

We only allow such processors to process your data for certain purposes and in accordance with our instructions. However, you can ask us, in compliance with the transfer a list of who are these companies that provide services to us, you can do so by email: Dataprotection@quartiersproperties.se

7. Data Security

We have implemented appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorized manner, modified or disclosed. In addition, we limit access to your personal data to those employees, contracting agents and other third parties who have a commercial need to know such data. They will only process your personal data in accordance with our instructions and will be subject to a duty of confidentiality.

We have implemented procedures to deal with any suspected breach of your personal data and will notify you and the Supervisory Authority in the event that a security breach occurs, as regulated in the GDPR in Articles 33 and 34 thereof.
